**Green Souvenir** - Udruzenje ljubitelja Gorice i prirode

The project objectives are establishment of the efficient plant waste recycling, management system development for biodegradable waste, encouragement and affirmation of activities for waste reduction, practical trainings for souvenirs manufacturing, development activities of NGOs related to the circular economy.

The project Green Souvenir is directly related to the objectives of the env-net call:

- To contribute to the development of knowledge and critical understanding circular economy model opportunities;
- Circular economy concept “activitis of NGO related to the circular economy;
- The promotion and engagement of small CSOs active in campaigning and advocacy on environment to promote effective actions for the benefit of citizens.

**Monitoring the progress of negotiations in the field of nature protection through monitoring of success in combating poaching “Center for research and protection of birds “CZIP**

The main objective of the project is to strengthen the involvement of the civil sector in campaigns and advocacy in the field of nature protection, especially in the negotiation chapter 27, through the monitoring of the legislative framework in hunting, as well as assessing the consequences that the bastards have on the subaltern: nature protection.

Taking into account that this project will focus not only on monitoring the negotiations under Chapter 27 with a very specific topic, the activities will be directed to public advocacy in order to actualize and monitor the problems of the curators at the negotiation level. In addition, through inclusion of the media in reporting this problem to the public, the project results, collected and processed data with estimates, will have a significantly greater echo in the general public, which is crucial for the successful implementation of the project.

The main result of the project is the increased engagement of the civil sector in campaigns and advocacy under Chapter 27, in particular the protection of nature, with close cooperation with the media. In addition, it is expected that the project will help to increase the visibility of the problem of curves in the wider public. The key result of the project will certainly be the relevance and justification of the efforts invested in the actualization of the problem of the criminal within Chapter 27.
